(IPG) programmes across Government Degree Colleges of J&K, it is hereby notified for the information of all concerned candidates that the initial window for fresh registrations and preference-filling, was opened from 23-06-2026 to 26-06-2026, and subsequently the Round-3 (Direct System Allotment) List has been published on the Centralised Admission Portal (<https://jkadmissions.in>) on **29-06-2026**.

In order to ensure maximum opportunity for aspirants and to facilitate the filling of any remaining vacant seats, the Centralised Admission Portal will **re-open for Fresh Registrations** for the 2nd Spot Round from 29-06-2026 onwards.

Walk-in admissions for courses (listed in Annexure 'A' of Spot Round Admission Notice No: DC-HE/2026/K/1830 Dated 23-06-2026) will remain open till the closure of admissions. Further, Direct System Allocation Selection Lists (listed in Annexure 'B') will be published periodically till required.
